

**RESOLUTION NO. 20145 (N.C.S.)**

**A RESOLUTION ESTABLISHING RATES FOR SANITARY SEWER SERVICES EFFECTIVE FEBRUARY 1, 2012**

**WHEREAS**, the City of Salinas owns and operates a municipal sanitary sewer collection system for the residents and the businesses within its service area. The existing sanitary sewer system comprises approximately 289 miles of sewer pipe. All sanitary sewer wastewater collected by the City's system flows to the Monterey Regional Water Pollution Control Agency's (MRWPCA) Salinas Pump Station; and

**WHEREAS**, the City of Salinas levies charges for sanitary sewer services pursuant to Salinas City Code Section 36-20.5 and pursuant to California Health and Safety Code Section 5470 et seq.; and

**WHEREAS**, the City periodically reviews the rate of such charges to determine that the charges will fully fund the City's sanitary sewer enterprise and proportionately allocate the cost of providing sanitary sewer service to the affected properties; and

**WHEREAS**, the City of Salinas has established a Sanitary Sewer Enterprise Fund to fund the operations, the maintenance, and the capital improvements needed for the sanitary sewer collection system; and

**WHEREAS**, the City of Salinas commissioned a Wastewater Financial Plan and Rate Study (Rate Study) to determine the annual rate-based revenue requirements of providing sanitary sewer collection services to the users of that service; and

**WHEREAS**, the City Council has initiated proceedings to revise the Sanitary Sewer Collector Fee that will be effective beginning February 1, 2012; and

**WHEREAS**, with the adoption ordinance no. 2528 on December 13, 2011, the Sanitary Sewer Collector Fee is to be established as a fixed rate set by resolution adopted by the City Council consistent with the Rate Study; and

**WHEREAS**, in accordance with Article XIID, §6 of the California Constitution, the Rate Study demonstrates that:

- a. The revenues derived from the Sanitary Sewer Collector Fee do not exceed the funds required to provide sanitary sewer service. The rate is established at a level needed to fund on-going operation and maintenance of the sanitary sewer system and to meet capital expenditures on the sanitary sewer system;
- b. The revenues derived from the Sanitary Sewer Collector Fee will not be used for any purpose other than sanitary sewer service;
- c. The Sanitary Sewer Collector Fee will not exceed the cost of providing sanitary sewer service attributable to each parcel;
- d. The Sanitary Sewer Collector Fee pays for the provision of sewer service and not for general governmental services.

**WHEREAS**, mailed notification of the proposed change to the calculation of the Sanitary Sewer Collector Fee was sent to property owners on November 23, 2011, in compliance with the required 45-day notice and comment period in accordance with Proposition 218 (Article XIII D, section 6, of the California Constitution); and

**WHEREAS**, this public hearing is conducted regarding the proposed changes to the Sanitary Sewer Collector Fee and all protests against the rates and other comments will be considered.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF SALINAS THAT:**


- 1) The foregoing recitals are all true and correct and are incorporated herein by reference.




