1) No signs shall be installed within the public right-of-way, on public sidewalks, or at locations that will obstruct driver's safe line of sight.		
2) Hoses used for the car wash must include automatic shutoff nozzles as required by the Salinas Water Conservations Ordinance. Water use shall be minimized.		
3) A stacking or queuing distance for 5 vehicles (100ft) must be provided without traffic backing into the public right-of-way.		
4) The on-site traffic control and circulation plan shall be provided to the Salinas Public Works Transportation Section for review and approval. No traffic controls shall be placed within the Public right-of-way unless specifically required by said Section.
